May please find attached herewith a Monthly Progress Report (MPR) of National WAMSI Project (WAMSI: Waqf Assets Management System of India) for the Month of February 2018. It carries the regular statistics on the progress of data entry as on February 28, 2018 in all the Modules including GPS Survey & Photography of Waqf Properties under WAMSI On-line System and increments thereof with respect to last month data progress. Highlight of this month update is the Training conducted for the Staff of Waqf Board Andaman & Nicobar Islands at Port Blair during January 29 to February 02, 2018. As a Hands-on Field Experience, participating Staff were trained to conduct GPS Survey & Photography using NIC developed "WAMSI Data Catch v1.1 Mobile App" by visiting few identified Immovable Waqf properties. Since they are the right persons knowing their Waqf properties boundaries, so, Vertices of the Waqf Properties could easily be identified on the Field, which is the crux of GPS Survey and GIS Mapping for the WAMSI On-line System.

It is indeed our pride privilege to mention here that **Karnataka State Waqf Board** is the only Waqf Board as observed in this month MPR that they have entered maximum Data in all the Modules of WAMSI On-line System leaving all Waqf Boards behind. This month they have added **535 more** Immovable Waqf Properties, filed **1,184 more** Mutawalli Annual Returns, Tracking **515 more** Litigation Cases. Congratulations to Hon'ble Administrator, Officers and Staff of Karnataka State Waqf Board for taking lead although started late. Moreover, it is also required to place on record that **Haryana Waqf Board**, which is conducting GPS Survey & Photography using "WAMSI Data Catch v1.1 Mobile App", have added **379 GPS Surveys** and **358 sets of Photographs** of their Waqf Properties this month. Congratulations.... Public can vouch through this "Public Interface" for the "welfare measures" taken by the Mutawallis (i.e., Managers/Trustees/Managing Committees) out of the revenue generated from Waqf Properties under their supervision, in the service of genuine, poor and under-privilege sections of the society as per the noble concept of Auqaf or intention of Waqif. Public may also monitor the Status of Annual Returns filed by the Mutawallis, whereby they were required to submit the details of Welfare Measures alongwith Income, Expenditure and State Waqf Board Contribution for each financial year.

Looking forward to your continued guidance, help & support in the service of an efficient management of Waqf Properties in India. So, as to get optimum revenue and also to keep them protected from vested interests such as encroachers, land mafia, etc, for all the time to come. It is further to inform you that MPRs are normally uploaded by the first week of every month under the "Progress" Hyperlink. 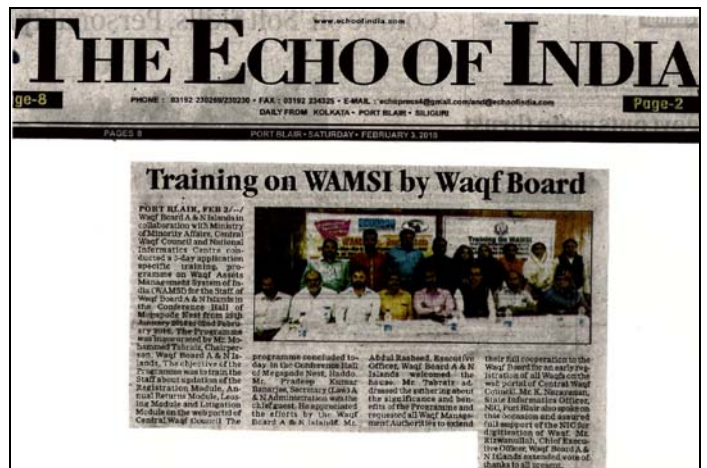
Training of staff of Waqf Board Andaman & Nicobar Islands on WAMSI on-line System
