1. Person/firm/s who are interested shall submit their Tender in a sealed cover in their own handwriting addressed to the Chief Executive Officer, Karnataka State Board of Auqaf, No.6, Cunningham Road, Bengaluru-560052
2. The Tender Should be submitted in a sealed cover subscribed as "Tender for the Disposal of Board's Vehicles (1) Armada No.KA 04 N-9686 (2) Commander No.KA 04-P-2613.
3. The Tenderer shall enclose alongwith the Tender a sum of Rs.10,000/- D.D (Rupees Ten Thousand only) for each Vehicle as EMD in favour of Chief Executive Officer, Karnataka State Board of Auqaf, Bengaluru. The said EMD will not carry any interest
4. The Tender in respect of which EMD is not deposited shall be summarily rejected
5. The Tender shall not be conditional, and if so, the same will be rejected
6. The intending firm or person may inspect the 02 (Two) Vehicles (proposed for Auction) at the Board's office during office hours
7. The Car will be disposed of on "AS IS WHERE IS" basis and should be cleared as such. No correspondence in this behalf will be entertained.
8. The Tenderer shall also be entitled to bid at the Auction.
9. Every bidder at the Auction Sale shall deposit an E.M.D. of Rs.10,000/- for each vehicle. The EMD will be received from the intending firm/person upto 3.30 p.m. on 12-03-2018 and a receipt in token of having paid the EMD will be issued by the Cashier of this office.
10. A person who has not deposited the EMD as prescribed shall be disqualified from taking part in the Auction.

11. The officer conducting the Auction sale may at their discretion to refuse or accept any bid or offer of any person/firm without assigning any reason
12. The Auction shall be conducted and the highest bid/Tender shall be accepted. The signature of the bidders/tenderers shall be taken to the bidder list and tenderer lists. The sealed Tenders shall be opened immediately after the Auction in the presence of the Tenderers/Bidders present before confirmation of the sale. The officer conducting the Auction sale may accept the highest offer received either through the tender or at the Auction sale whichever is the highest as deem fit and at his absolute discretion.
13. The successful bidder/Tenderer shall pay the entire amount within (3) three days of receipt of the confirmation of the bid or offer, failing which the EMD deposited shall be forfeited to the Board and the Vehicles will be sold by Auction once again.
14. The sale shall not be completed until the same is confirmed by the Administrator, Karnataka State Board of Auqaf, Bengaluru
15. In the event of any dispute arising in connection with the Tender-cum-Auction sale at the time of Tender or Auction, the decision of the officer/s conducting the Auction sale shall be final and binding on all the parties to the Auction sale
16. The E.M.D of both unsuccessful bidders and unsuccessful tenderers will be refunded
