Subject: Enumeration of persons indulged in begging before the major Mosque's in each taluk headquarters.

In the circulars referred to above instructions were issued to initiate action for eradication of beggary before the Masjids. All the Waqf officers are directed to conduct the enumeration of persons indulged in beggary in the major mosques at each of the taluk headquarters in the district. The enumerator may be appointed to each of the taluk from among the officials of DWAC. The enumeration shall be conducted at least in four Jumma prayers in form 2 and the consolidated details maybe furnished in form 1. The enumeration shall be started immediately after ramzan and report may be furnished after completion.
