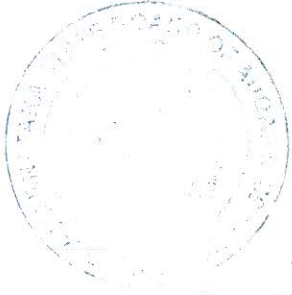


**PROCEEDINGS OF THE ADMINISTRATOR, KARNATAKA STATE

The term of the District Waqf Advisory Committee, Uttar Kannada Constituted vide order No. KSBW/ADM/CR/627/2010-11 Dated: 07-08-2015 for a period of three (03) years & the term expired on 06-08-2018.

The subject was placed before the Administrator, Karnataka State Board of Auqaf, Bengaluru for formation of New District Waqf Advisory Committee and the Administrator has accorded approval for the Constitution of fifteen (15) members with Chairman and two (02) Vice-Chairmen to the District Waqf Advisory Committee, Uttar Kannada District, for a period of three (03) years as per Notification No. MWD 114 WES 2008 dated 10.05.2011.

In exercise of the Powers conferred under the provisions of the Waqf Act, 2013 read with Karnataka Waqf Regulation, 2010, the Karnataka State Board of Auqaf, Bangalore, hereby constitutes the District Waqf Advisory Committee, Uttar Kannada District for a period of three (03) years w.e.f. 20-08-2018 to 19-08-2021 or until further orders or whichever is earlier.

The District Waqf Advisory Committee shall function in accordance with the provisions of the Waqf Act, 1995 and Karnataka Waqf Rules, 2017, and the Rules framed hereafter by the Government, Notification No. MWD 114 WES 2008 dated 10.05.2011 and the directions issued by the Karnataka State Board of Auqaf, Bengaluru from time to time subject to the following conditions.

1. The Chairman, Vice Chairmen and the Members of the District Waqf Advisory Committee shall not be a tenant or lease holder of any of the Waqf.
2. The Chairman, Vice Chairmen and the Members of the District Waqf Advisory Committee shall not be an undischarged/convicted for any criminal offence.
3. The Chairman, Vice Chairmen and the Members of the District Waqf Advisory Committee if subsequently found that any Wrong/misleading information is provided to the Board they are liable to be disqualified without any notice.
4. If it is found that any of the office bearer/member of the District Waqf Advisory Committee are facing any of the Enquiry under Sec. 52, Sec.54 of the Waqf Act. or KPP Act. their name will be deleted without Notice.
5. If for any reason the continuation of the Chairman/Vice Chairmen/Member is found to be detrimental to the interest of the Waqf Institution or obstruct the discharge of functions of the Committee, they are liable to be removed without any notice.
6. The Chairman, Vice Chairmen and the Members of the District Waqf Advisory Committee shall take oath as per govt. circular No. MWD/181/WES/2017 Dated: 12-12-2017 & a copy of the same to be furnished to the Chief Executive Officer, KSBA.
