The cases of unauthorized occupation of Waqf properties registered with the Karnataka State Board of Auqaf are being adjudicated under the provisions of the Karnataka Public Premises (Eviction of Unauthorised Occupants) Act 1974, before the competent Officer under the K.P.P. Act-1974. The competent Officer has passed orders for the eviction of the unauthorized occupants from several Waqf properties, in the State. The authorities of Waqf institutions who have approached for the eviction of unauthorized occupants under Section 5(2) of the K.P.P. Act -1974, action has been taken for the appointment of Authorised Officer to evict the unauthorized occupants and accordingly unauthorized occupants have been evicted the details are as follows:-
